NOTES FOR ASSOCIATES

- The Kunst Grenzen Association - Frontier Art (KG) will be able to participate in events organized with other Art Galleries and curators. For this reason and in any case exclusively for our associates, it will be possible to participate in events organized with others Associations, following agreements established from time to time;
- The KG Cultural Association undertakes to accept a small-format work by the artist, to exhibit it in a event and the other, for the entire period of membership of the Association, on the premises of the Art Gallery located in Italy, Via Villotta 7/A - 38030 Roverè della Luna (IT-TRENTO);
- During this period the artist will be able to share this image (which documents the event exposure) on their websites accompanied by their personal notes;
- The member can exhibit at the Kunst Grenzen Art Gallery by participating, if interested, to all the activities and initiatives that KG intends to promote, subject to the payment of reimbursements expenses verified and communicated from time to time to participate in the event;
- To be able to post a video of limited duration on the website of the gallery relating to yours artistic production. The video will be shot at the artist's expense and will have to respond to SIAE regulations in force or, for abroad, the regulations of similar bodies relating to copyright. This restriction will also be extended to the publication of third parties who have shot and produced the video;
